Dear Parents and Guardians:

Each year the school plans a trip for our Grade 8 students which is both a meaningful educational experience and an opportunity for the students to socialize and enjoy themselves as they come to the close of their middle school years. This year's trip is scheduled for June 14th, 15th, and 16th. Last year, we had a very successful trip to Pennsylvania and the students and faculty all agreed that it was a wonderful experience. This year we have put together a similar trip, including a guided tour of Philadelphia, the Indian Echo Caverns, a tour of the Amish country and farm stands, a movie about an Amish teen named "Jacob's Choice", a live performance of "Newsies" at the Fulton Theater on the second night and admission into Hershey Park and Chocolate World on the third day.

The travel agent has asked for a count of students planning to go and therefore we are requesting that students bring in an initial deposit to reserve a seat on the bus. The cost of the trip is \$475.00 per student. This includes all transportation, accommodations, admission fees, two breakfasts and two dinners. Students will be able to apply funds earned from the last two years' magazine sales, as well as funds from this year's sale, toward the trip. We must, at this time, request a **\$275** deposit from each student planning to attend the trip.
